INITIATION FEE AGREEMENT

Rochester Yacht Club initiation fees are due upon joining. The Board of Directors, as a convenience to new members, allows payment of initiation fees in installments. If over 41 upon joining, maximum payment term is 60 months.

I understand that this method of payment is purely for my convenience and the entire initiation fee is due upon joining the Rochester Yacht Club. No interest shall be due provided I, the undersigned, remain a member of Rochester Yacht Club and pay the amounts set forth above. Customary finance charges shall still apply for unpaid balances on member's accounts.

If I resign, or if my membership is terminated, the unpaid balance of the initiation fee is immediately due and payable. If I fail to immediately pay the unpaid balance, interest shall accrue at an annual rate of 24% and I will be liable for all collection expenses, including reasonable attorney's fees.
